ORDER UNDER SECTION 12AA OF THE INCOME TAX ACT, 1961

**M/s. St. Jude Public School Charitable Trust, Elamthuruthy, Kuttanellur, Thrissur, a Trust created as per Trust Deed executed and registered with the Sub Registrar, Kuttanellur on 12/12/2014 has filed an application in the prescribed Form No.10A on 14/12/2015 requesting for Registration under section 12A of the Income Tax Act, 1961.**

- The Trust / Institution is registered U/s.12AA(1)(b)(i) of the Income Tax Act w.e.f. the previous year relevant to the **Assessment Year 2016-17** and its name is entered at CIT(E)/CHN/12A/226/2015-16 in the register of application under section 12AA maintained in this office, as a **Public Charitable Institution**. The **Unique Registration Number** allotted against the name of the Institution is **AAOTS8918D/09/15-16/T-0218**.
- The registration u/s.12AA (1)(b)(i) of the Income Tax Act, 1961 does not automatically exempt the income of the Trust/Institution. The question of taxability of the income of the Trust/Institution shall be examined and decided upon by the Assessing Officer at the time of assessment based on the conduct of the activities, compliance with various statutory and other requirements, etc., as referred to in Sections 2(15), 11, 12 & 13 of the Income Tax Act, 1961, without prejudice to the fact of granting merely in principle registration by this order.
- This Certificate is not a finding regarding the charitable/religious nature of the Trust/ Institution and is only to the effect that the applicant's name has been entered in the register maintained in this office.
- With effect from the Assessment Year 2009-10, the advancement of any object of general public utility other than relief of the poor, education and medical relief as defined in section 2(15) of the Income Tax Act shall not be a charitable purpose, if it involves the carrying on of any activity in the nature of trade, commerce or business, or any activity of rendering any service in relation to any trade, commerce or business, for a cess or fee or any other consideration, irrespective of the nature of use or application, or retention, of the income from such activity.


