3. Status of the Trust:-

St.Jude Public School Charitable Trust (CBSE) Kuttanellur belongs to the Christian Minority Community.

4. Area of Operation:-

The area of operation of the Trust shall be within the territory of India.

5. Objects of the Trust:-

The benefit of this trust will be made available to all public irrespective of religion, caste, creed, colour, community and sex.

The objects for which the Trust is established are as follows:-

- f) To impart training in the field of health, science and technology to increase the employment potential of the youth;
- g) To establish, organize, assist, subsidize and/ or take over educational and training institutions for the benefit of the public and students in particular;
- h) To offer full-time, part-time and short-term programmes to upgrade the technical skills of the young and talented;
- i) To establish and manage professional institution, boarding houses, hostels, libraries, etc. for the purpose of spreading education;
- j) To organize, provide and maintain facilities for holding lectures, seminars, classes, studies, courses of work, examination and tests and conferment of Degree, Diploma and certificates for professional studies, training or other attainment and holding of competitions in connection with professional subjects;
- k) To arranging for, and give, awards and prizes, and to provide, establish, institute, administer, conduct and undertake grants, scholarships, research fellowships and other benefactions;
- l) To print, publish and distribute reports, journals, periodicals and other relevant literature intended to promote the objectives of the Trust;

- r) To run special schools for differently abled people and/or financially help the institutions which run such special schools

6. Ways and Means

In order to attain the above said aims and objects, the Trust shall be at liberty to accept contributions and donations, whether in cash or in kind by way of any movable and/or immovable properties.

The Trustees may accept donations, grants, subscriptions, aids or contributions from any person, Government, Local authorities or any other charitable institutions, in cash or in kind including immovable property without any incumbrance, but the Trustees shall not accept any receipt with any condition or terms inconsistent with the objects of the Trusts. While applying such receipts to the objects, the Trustees shall respect the directions, if any, by the granter. Any receipt with specific direction to treat the same as part of the corpus of the Trust or separate fund shall be funded accordingly.)

- i) All monies, which shall not immediately required for current needs shall be invested by the Trustees in eligible securities and investments, or in banks. Such investments shall be in the name of Trust or Trustees.
- ii) That the trustees shall invest the trust fund, carry on any business with the trust fund and/or enter into partnership on behalf of the trust, as they may deem fit.
- iii) That the trustees shall manage the trust fund and investments thereof as a prudent man would do the same. They shall recover all outstanding and meet all recurring and other expenses incurred in the upkeep or management thereof.
- iv) That the trustees shall receive and hold the income of the trust on behalf and for the benefit of the beneficiaries under the trust.

7. Board of Trustees:-

The Trustees shall collectively be called the Board of Trustees, hereinafter referred to as the Board. The overall administration, management and control of the Trust shall vest in the Board. The Board shall function as per the provisions of the statutes, rules and regulations of St Joseph Province. The Provincial Superior of St. Joseph's Province, ex-officio member, shall be the Chairman of the Board. The Board shall elect from among themselves a Secretary and a Treasurer. - 8. The Board shall have the following powers and duties:-**
- a) To organize, administer and control the activities and programmes of the Trust, Trust properties, and the institution established by and belonging to the Trust or under its management.
 - b) To chalk out ways and means to raise funds by donation or otherwise for financing the programmes in fulfillment of the objectives of the Trust and executing them.
 - c) To borrow amount or to continue to avail of the amount already borrowed from individual, banks, financial institutions, with or without interest for any object of the Trust.
 - d) To purchase or otherwise acquire for the Trust, any property whether movable or immovable, at such terms and conditions, as the Board thinks fit. The Board shall have power to sell or otherwise dispose of or mortgage any of the properties of the Trust at any price and such terms and conditions for the attainment of any of the objective of the Trust in the best interest of the Trust.
 - e) To acquire by gift, purchase, hire, exchange, lease, or otherwise, suitable land, vacant or with buildings, and to build or acquire building, furniture, equipment vehicles etc.

- f) To sanction funds for meeting the expenses of the Trust and its activities and also to grant scholarships and to provide funds for the poor students.
- g) To appoint or employ such staff as may be necessary for efficient management of the institutions owned and run by the Trust, and to prescribe duties of, and to take, where necessary, disciplinary action against, any of the employees of the Trust. The appointment of the staff should get approval in a meeting in which the ex-officio chairman is present.
- h) To institute, conduct, defend, compound and abandon any legal proceedings by or against the Trust.
- i) To appoint auditors for scrutiny of accounts and to make reports thereon.
- j) The Board shall have the power to rent out/lease out the Properties of the Trust and also to take on rent, lease or hire purchase, any items required for the satisfactory fulfillment of the object of the Trust on such terms and conditions as decided by it.
- k) To develop, extend, improve or alter and equip all the works and activities of the Trust in such a manner as the attainment of any of the objectives of the Trust
- l) To invest the funds of the trust, in bank or in the purchase of company shares or securities or other movable and movable and immovable properties
- m) To open the bank accounts in the name and on behalf of the trust and to operate the same accounts in the name and on behalf of the trust .
- n) To nominate their representatives for any of the aforesaid purposes.

9. Meeting of the Board:-

- a) The Board shall meet as often as required, but shall meet at least once in six months
- b) There shall be at least 5 day's notice for the meeting of the Board; unless the requirement of the notice is waived unaimously by all the members of the trust and recorded that fact in the minutes
- c) The quorum for the meeting shall be two-third of the Strength of the Board;
- d) All decisions of the Board shall be taken by majority votes and all major decisions and policy matter shall be subject to the approval of the Provincial Council

10. Patron:-

The Provincial Superior of St. Joseph Province Kennedymukku, Thrikkakara P.O., Ernakulam District, Pin.682021 Kerala State shall be the patron of the Trust. The patron shall have power at any time to appoint, reappoint or remove the members of the Board.

11. Chairman:-

The Chairman of the board shall be the overall in-charge of the Trust. The activities of the Trust shall be conducted by her under the general supervision and guidance of the Board. She shall also preside over the meetings of the Board

12. Secretary:-

The Secretary of the Board shall be elected from the Trustees. The responsibility of the Secretary shall include convening the meeting, preparing minutes, assisting the Board in its correspondence, liaising with Government and other agencies.

13. Treasurer:-

The responsibilities of the Treasurer shall include the following;

- a) Maintaining the accounts of income and expenditure of St.Jude Public School (CBSE) Kuttanellur.
- b) Preparing monthly/yearly accounts and furnishes them with the approval of the Board.
- c) Producing the accounts and related documents of 'St.Jude Public School (CBSE) Kuttanellur before the auditors and get the accounts audited by a qualified Chartered accountant.
- d) Maintaining all records related to financial and property matters of 'St. Jude Public School (CBSE) Kuttanellur

14. Trust Fund:-

The Trust Fund is **Rs.50,000/- (Rupees Fifty Thousand Only)** which the settler has made over to the Trustees to hold the same together with all additions and accretions thereto and all properties that may be acquired by purchases, lease, gift, donation or otherwise and shall be the subject matter of the Trust (hereinafter called the Trust Fund) for the objects and on the terms and conditions contained herein.

15. Income derived out of Trust Fund:-

The income of the Trust shall be used solely for the promotion of the aims and objects of the Trust and no portion thereof shall be paid or transferred directly or indirectly, by dividend, bonus or otherwise by way of profit to the Trustee. However, all expenses incurred by the Trustees to discharge their duties as Trustees Shall be met from the Trust Fund.

16. Investments:-

Investments of the Trust Fund shall be made only in accordance with the provisions contained in Section 11(5) of the Income Tax Act, 1961.

17. Bank Accounts:-

The Trust shall maintain bank account(s) approved by the Board and shall be operated jointly by persons as authorized by the Board

18. Financial Year:-

The financial year of the Trust shall be 1st April to March 31st of the succeeding year.

19. Annual Meetings of the Board:-

A meeting of the Board, called the Annual Meeting, shall be held not later than the 30th day of June every year. The treasurer of the 'St. Jude Public School Religious Charitable Trust (CBSE) Kuttanellur', is responsible for getting the audit report and financial statements of the Trust by a qualified chartered accountant sufficiently early and to place such reports before the Annual Meeting of the Board.

20. Saving Clause:-

It is expressly declared that this is a charitable Trust and that no part of the Trust Fund or its income shall be applied for any purpose other than charitable in nature.

21. Indemnity:-

Every constituent of the Board shall be indemnified out of the funds of the Trust against all expenses and losses incurred by them in the discharge of their duties and also such loss or damage which has incurred not through their willful neglect or default.

22. Amendments:-

The Board shall have, inconsistency with the aims and objectives of the Trust, as herein before set out, the power to add, amend, repeal or modified any of these rules by a 2/3 majority subject to the prior approval of the jurisdictional commissioner of Income Tax.

Any amendment that alienation of immovable properties will be carried out only with the prior approval of the jurisdictional commissioner of Income Tax.

23. Revocability:-

St.Jude Public School (CBSE) Kuttanellur, created by this Deed of Trust shall be irrevocable in nature

24. Dissolution:-

When the Board feels that in the best interest of the public it is better to windup Trust and the objects of the trust can better be achieved by some other manner, they shall submit the proposal to the Patron for her decision, and action shall be taken according to her directions

If the decision of the Patron is to windup the Trust, the assets and the liabilities of the Trust shall be transferred to any Trust/ Charitable Institution with similar aims and objectives of the Trust duly registered under the prevailing laws or to the Government. In the event of dissolution or winding up of the Trust the assets remaining as on the date of dissolution shall under no circumstances be distributed amongst the Trustees.

The value of this trust deed is **Rs.50,000/- (Rupees Fifty Thousand only)**

The Stamp duty of **Rs.3,000/- (Rupees Three Thousand only)** for Trust Fund of **Rs.50,000/- (Rupees Fifty Thousand only)** is levied.

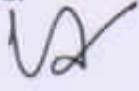

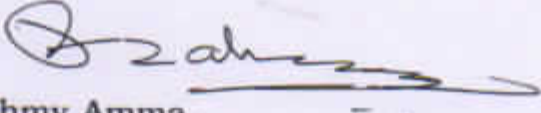
